Key Responsibilities

- Design, launch, and manage LCEF's Approved Vendor System, including vendor onboarding, compliance, and performance monitoring.
- Manage scopes of work, deliverables, and compliance tracking for CBOs, workforce development providers, and tools such as SolarAPP+
- Track the performance of the vendor and TA contracts
- Manage external partnerships with technical assistance providers, community-based organizations, and implementation partners to ensure alignment with program goals.
- Coordinate the drafting and submission of semi-annual reports to the EPA, aggregating data and outcomes from across implementation teams.
- Oversees vendor eligibility, manages CBO and workforce partner engagement, and ensures quality assurance across technical assistance and implementation support contracts.
- Deliver technical assistance to partners and monitor deliverables, ensuring compliance with scope, budget, and EPA requirements.
- Participate in the scoring and evaluation of partner RFP responses, applying consistent criteria and ensuring transparency.
- Ensure vendor alignment with LIDAC participation goals, workforce equity standards, and Solar for All program impact metrics.
- Represent LCEF at community meetings, conferences, and other public events.
- Other duties as assigned by the Solar for Y'all Program Director
